## PREQUALIFICATION DOCUMENTS

The following prequalification documents are required:

- 1. Photocopy of Certificate of Incorporation, Business Registration in Nigeria.
- 2. Photocopy of company Tax Clearance Certificate for the last three (3) years (2020, 2021 and 2022).
- 3. Photocopy of Value Added Tax (VAT) Registration Certificate and evidence of VAT remittances.
- 4. Company's Audited Accounts for the last three (3) years (2020, 2021 and 2022), duly signed.
- 5. Comprehensive Company profile including details of the Management and Professional staff and copy of Company Brochure with convincing evidences of technical and operational competence to undertake the relevant project(s).
- 6. Evidence of adequate relevant equipment and facilities to execute the project(s).
- 7. Evidence of legal capacity to enter into contract. i.e., the company is not in receivership.
- 8. Evidence of financial capability to execute the project(s). This shall include certified statement from a reputable Bank. (Bank reference letter only is NOT ACCEPTABLE).
- 9. Verifiable evidence of previous experience i.e., having satisfactorily and successfully executed similar project(s) in the last five years.
- 10. Evidence of manufacturer's accreditation; Manufacturing Companies MUST submit evidence of relevant manufacturing capability(s), facility(s) and SON or ISO Certificate.
- 11. Test certificate issued by well-known International Standard Test Laboratory for Manufacturers of Equipment.

- 12. Sample of Test Report of Manufactured Equipment.
- 13. For OEM/Representative, Evidence of EC/KEMA Certification or equivalents MUST be submitted.
- 14. Evidence of Compliance with Pension Act, NSITF, ITF and evidence of remittances.
- 15. Sworn Affidavit affirming that none of the Directors of the Company was ever convicted in a Court of Law.
- 16. Evidence of Corporate Social Responsibility (if applicable).
- 17. Evidence of Corporate Environmental and Governance Policy (if applicable).
- 18. Any other relevant document(s) that will place the company on a competitive advantage.

Contractors, etc. who qualify for any or all the categories may apply for Pre-qualification.

Contractors, etc. who meet the criteria above will be prequalified for the categories applied for, and will form the list of contractors, etc. who will be issued tender documents to bid for execution of project(s) and supply of goods and provision of services under relevant categories.
